Release and Waiver of Liability

In consideration of my child being permitted to participate in activities associated with **Dragon Mandarin Immersion School**, including but not limited to the **playground, gym, school grounds, and surrounding vicinity**, I, the undersigned parent/legal guardian, hereby **release, waive, discharge, and covenant not to sue** Dragon Mandarin Immersion School, its officers, directors, employees, agents, volunteers, and representatives from any and all liability, claims, demands, losses, or damages arising out of or related to my child's participation in such activities.

This release applies to any injury, illness, property damage, or death that may occur while my child is participating in playground, gym, school grounds, or vicinity activities, **except in cases of gross negligence or willful or wanton misconduct** by Dragon Mandarin Immersion School, its agents, or employees.

Indemnification Agreement

I further agree to **indemnify and hold harmless** Dragon Mandarin Immersion School, its agents, and employees from any and all claims, liabilities, losses, damages, costs, or expenses, including

reasonable attorney's fees, arising from or related to my child's participation in the activities described above, except in cases of gross negligence or willful or wanton misconduct.

This indemnification applies whether such liability is alleged to be sole, joint, or several.

Assumption of Risk

I understand that participation in playground, gym, and school grounds activities may involve physical exertion and inherent risks. I acknowledge and accept these risks and represent that, to the best of my knowledge, my child is in good physical condition and able to participate safely.

I acknowledge that Dragon Mandarin Immersion School may not have medical personnel present during playground or related activities and that such information has been provided during registration.

Medical Authorization

In the event of injury or illness, I understand that I will be notified as soon as possible. If I cannot be reached and an emergency exists, I hereby authorize Dragon Mandarin Immersion School and attending medical personnel to obtain emergency medical treatment for my child, including hospitalization, anesthesia, injections, or surgery as deemed necessary for my child's safety.

General Provisions

I understand that participation privileges may be revoked at any time at the sole discretion of the school or supervising staff.

I certify that I have carefully read this agreement, fully understand its contents, and sign it voluntarily with full knowledge of its significance and legal effect.
